04. COMBINATION. Parcels with a combined residential/commercial use, or a building with stores or shops on ground floor and dwelling units on upper floor(s).
05. COMMERCIAL I. A business property of small or medium size having a maximum value of \$100,000.

Taxes are payable to the Tax Collector at the Tax Collector's Office, Town Hall, 195 Danielson Pike, PO Box 328, Scituate, Rhode Island 02857.

The tax rate on residential real estate is \$24.57 each \$1,000 at 50% assessment ratio; for commercial/industrial/mixed use including utility is \$30.89 each \$1,000 at 50% assessment ratio; and for tangible personal property is \$36.79 each \$1,000. The tax rate on retail and wholesale inventory is exempt by the Scituate Town Council. The motor vehicle excise tax rate is \$30.20 each \$1,000. The current rate is apportioned as follows:

School Purposes	71.47%
Municipal Purposes	<u>28.53%</u>
Total	100.00%

All taxes are due and payable July 1, 2006, and on and after August 1, 2006 draw interest from July 1, 2006 until paid at the rate of 12 per centum per annum, as a penalty. (See schedule for installment payments.)

STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS RESOLVED:

That the electors of the Town of Scituate qualified to vote on any proposition to impose a tax, in Town Meeting legally assembled, on this 4th day of April A.D. 2006 hereby order the levy and collection of a tax on the ratable real estate and ratable personal property in a sum not less than \$20,086,630 (twenty million, eighty six thousand, six hundred and thirty) nor more than \$21,422,626 (twenty one million, four hundred twenty two thousand, six hundred and twenty six), plus the average of the last three years abatements, (estimated at \$51,803). Said tax is for the ordinary expenses and charges for the payment of interest and indebtedness in whole or in part of said town and for other purposes authorized by law.

The Tax Assessor shall apportion said tax on the inhabitants and ratable property of said Town as of the 31st day of December A.D. 2005 at twelve, midnight, according to law, and shall on completion of said levy, date, certify and sign the same and deliver to and deposit the same in the office of the Town Clerk.

Now, therefore, I the undersigned assessor of taxes of said Town of Scituate, having been duly appointed, sworn and engaged, and having given due notice as the law requires by posting a notice in a local newspaper for three weeks and posting up printed notices thereof in three or more public places in said town for more than three successive weeks next preceding the 31st day of January A.D. 2006 (the day appointed in and by said notices for bringing accounts) to wit: in the Town Clerk's Office, North Scituate Post Office, Hope Post Office, and in other places in said Town, did as of the 31st day of December A.D. 2005 at twelve o'clock midnight, assess and apportion said tax on the ratable property in said town as hereinbefore written and set forth in the preceding pages of this book, and have this 15th day of June A.D. 2006 delivered to and deposited said assessment in the office of the Town Clerk of the Town of Scituate.
